- Child Tax Credit (but NOT Working Tax Credit*) and an income less than the amount set by the government (to find out this amount search for "Free School Meals" on www.bradford.gov.uk.
- Universal Credit
- AND they attend a tax payer funded nursery or school in the Bradford district. Children at nursery before and after lunch on any day, will be entitled to Free School Meals If your child attends a school outside the Bradford district, apply to the local authority where the school is.

*Where a parent is entitled to Working Tax Credit 'run-on' (a payment they may get for 4 weeks after they stop qualifying for Working Tax Credit) their children can get Free School Meals for this period.
